



SALINE COUNTY BOARD OF COMMISSIONERS

The regular meeting of the Saline County Board of Commissioners was called to order at 9:30 a.m. on Tuesday, September 3rd, 2019 by Chairperson, Marvin A. Kohout. Present were Kohout, Janet J. Henning, Stephanie A. Krivohlavek, Phil Hardenburger, and Russ Karpisek, Commissioners, Deputy County Clerk Anita Bartels and Administrative Assistant Tim McDermott. Deputy County Attorney Steve Reisdorff was present between court commitments.

Notice of said meeting was posted in the County Clerk's Office, on the Saline County Website, and published in all three county newspapers prior to the meeting, in compliance with State Statutes.

Let the record show that all proceedings are electronically recorded.

Kohout advised those present of the open meetings law posted at the back of the room.

Karpisek moved to approve the agenda, seconded by Henning. Voting aye were Karpisek, Kohout, Krivohlavek, Hardenburger and Henning, nays none, motion carried.

Krivohlavek moved to approve the minutes of the August 20th, 2019 meeting, seconded by Krivohlavek. Voting aye were Kohout, Krivohlavek, Hardenburger, Henning and Karpisek, nays none, motion carried

Under citizens' forum, Chuck McKay addressed the Board regarding the Windstream towers being raised in the County Right-of-Way. McKay's concerns were if the approval to occupy the County Right-of-Way should have gone through Planning and Zoning and the height of the towers. Reisdorff responded to the concerns, stating if the poles were in the County Right-of-Way, Planning and Zoning approval was not needed.

Jeff Koll questioned how long the Conditional Use Permit application, not approved because of a tie vote by the Commissioners, was active. Reisdorff explained because it was a tie vote, there is no time limit to resubmit an application for a Conditional Use Permit.

Under correspondence, Bartels reported receiving from the City of Crete, their September 3rd Agendas for the City Council Regular Meeting, Finance Committee Meeting, Public Safety Committee Meeting and Parks and Recreation Committee Meeting; from NIRMA the Clerk received two memorandums, one for the Nomination/Election of NIRMA Board Members, the other for the NIRMA Annual Membership Meeting and Luncheon & Dividend Distribution on October 4, 2019 in York.

Also, under correspondence, Kohout reported receiving a letter of confirmation from Randy Pryor, Extension Education, announcing his retirement on December 31, 2019.

At 10:00 a.m., CPA Brian Blobaum opened discussion on the 2019-2020 Budget. During the discussion it was noted there were extra ordinary large expenses for roads and court costs. Blobaum recommended a 3% tax increase, which would result in a \$10.00 increase per \$100,000 in valuation. Karpisek moved to approve a 3% tax increase, seconded by Henning. Voting aye were Krivohlavek, Henning and Karpisek, voting nay were Hardenburger and Kohout, motion carried. A Budget Hearing was set for 10.00 a.m., on Tuesday, September 17, 2019 in the Saline County Commissioners' Room, Courthouse, Wilber, NE.

At 10:20 a.m., Kohout announced the Board would take a short recess.

At 10:40 a.m., Kohout announced the Board would reconvene.

Planning and Zoning Administrator, Lyle Weber presented an application for a minor subdivision from Robert Malone to divide 3.030 acres in part of SW ¼ of Section 13 Township 16 North Range 4 East of the Sixth Principal Meridian, Saline County Nebraska. Karpisek moved to approve this minor subdivision, seconded by Hardenburger. Voting aye were Hardenburger, Henning, Karpisek, Kohout and Krivohlavek, nays none, motion carried.

At 10:45 a.m., Sandy Morrissey with Region V Systems, gave their annual update on programs and presented their budget request for 2019-2020.

At 11:00 a.m., Larry Dix, NACO Executive Director, presented Saline County with a \$4,744.56 Employee Wellness Grant. Dix congratulated Saline County on a well-organized and effective Wellness Program, noting Saline County was the only County which met all of the criteria for the grant.

Highway Superintendent, Bruce Filipi updated the Board on various road, culvert and bridge projects taking place.





County Treasurer, Deb Spanyers, presented Resolution #2019-73, whereas Farmers and Merchants Bank asked to release pledged securities in the amount of \$425,00.00, CUSIP #810164AQ6. Henning moved to approve Resolution #2019-73, seconded by Krivohlavek. Voting aye were Henning, Karpisek, Kohout, Krivohlavek, nays none, motion carried.

Spanyers submitted an itemized report covering the amount of uncollected taxes as shown by Distress Warrants returned by the Sheriff unsatisfied. The report included the number of the Distress Warrant, name and address of the taxpayer, amount involved, and reason given by Sheriff for failure to collect the same. Henning moved to approve the Uncollected Distress Warrant Report, seconded by Krivohlavek. Voting aye were Karpisek, Kohout, Krivohlavek, Hardenburger and Henning, nays none, motion carried.

NIRMA Board Member, Tim McDermott gave a synopsis of Saline County's membership with NIRMA. McDermott noted Saline County is a 1988 founding member and has received \$450,000 in dividend payments.

Henning moved to approve Resolution #2019-074 transferring \$800.00 from the #0100 General Fund to the #2250 Aging Services Fund, seconded by Karpisek. Voting aye were Hardenburger, Karpisek, Henning Krivohlavek and Kohout, nays none, motion carried.

Henning moved to approve Resolution #2019-075 transferring \$2,000.00 from the #0100 General Fund to the #2500 Grant Fund, seconded by Krivohlavek. Voting aye were Karpisek, Krivohlavek, Kohout, Henning and Hardenburger, nays none, motion carried.

Henning moved to approve Resolution #2019-076 transferring \$130.00 from the #0100 General Fund to the #2502 Emergency Preparedness Fund, seconded by Karpisek. Voting aye were Kohout, Hardenburger, Krivohlavek, Karpisek and Henning, nays none, motion carried.

Henning moved to approve Resolution #2019-077 transferring \$1,200.00 from the #0100 General Fund to the #2516 Juvenile Services Aid Program, seconded by Hardenburger. Voting aye were Krivohlavek, Henning, Hardenburger, Kohout and Karpisek, nays none, motion carried.

Henning moved to approve Resolution #2019-078 transferring \$142.72 from the #0300 Roads Fund to the #0100 General Fund, seconded by Krivohlavek. Voting aye were Henning, Kohout, Karpisek, Hardenburger and Krivohlavek, nays none, motion carried.

Under Report of Officials, Henning reported an upcoming LEPC meeting this Thursday and an RC & D meeting on Monday.

Hardenburger reported attending a Board of Director Training meeting last Wednesday, an RC & D meeting and announced a Household Waste Collection in Crete on September 7th from 11:00 a.m. to 1:00 p.m.

Kohout reported attending a Planning & Zoning meeting; Safety Committee meeting; Advanced Wellness meeting; Saline County Museum and Historical Society meeting and an Aging Services meeting.

Karpisek reported attending the Nebraska State Fair in the State Auditors Booth, hearing comments from citizens regarding County issues.

McDermott reported attending a Safety Committee meeting; the NIRMA Board Retreat; the Professional Development Academy, has a LEPC meeting on Thursday and will be in Jefferson County on Tuesday, representing NIRMA.

Henning moved to approve the claims as presented, seconded by Karpisek. Voting aye were Kohout, Krivohlavek, Hardenburger, Henning and Karpisek, nays none, motion carried.
