- Medicare Open Enrollment:
  - We had approximately 15 remote days between Crete, DeWitt, Dorchester, and Friend.
  - Clients saved a lot of money, and we are grateful to add new clients yearly.
- Health Fair in October 2024:
  - Dental by Public Health Solutions, Blood Pressure Checks, Downtown Family Vision and Flu Shots were also given by Public Health Solutions.
- Senior Events
  - We had Les Lineman, Musical Hats, Polka Band, and Music Bingo come to Western & Wilber Care Center to present their talents.
  - Crazy Cookie Mom and Velvet Barn Candles joined us for craft days and each client got to take home their own candle and cookies.
- TOGO Meals
  - In November, we had a Thanksgiving TOGO meal. We served approx. 45 people.
  - In January, we had a potato soup meal. We served 15 people.
- New Years Packages
  - Throughout the year, we receive donations, and we purchase the ingredients to make some kind of meal.
  - These packages are delivered to low-income senior citizens in Saline County with the help of 3 church groups in the area.
- Meat Packages
  - Brandon Campbell has been very helpful to get us meat donations through Cold Storage.

- February
  - We plan to have a craft day making a door sign.
  - Les Lineman will join us for entertainment at the Wilber Care Center.
- March
  - Velvet Barn Candles will present her business at the Wilber Care Center and following the presentation she will join us for a craft at the office.
  - Carly Applegarth from Gage County Extension will come to Western for a program.
- April
  - Jill Busselman plans to speak about her mission trip to Africa at the Wilber Care Center.
  - Caring Friends in-home care is coming to Western to share their services that they offer in the area.

- Hispanic Outreach

- Melissa gave an update on the DeWitt Center.
  - They had a health fair that included 35 vendors.
  - “Evening with Friends” is a new meal they started once a month in the evening. They enjoy a meal and visiting.
  - Once a month they also do a breakfast at a new business, they have had a good turnout each time.
  - They have been staying busy with programs craft days and meals.
  - DeWitt lost 18 seniors in 2024; they made bell ornaments in honor of each person.
- SCAT update –
  - Been working on the biannual budget and waiting on new vehicles.
  - They got a used vehicle from a transit place that closed.
  - They currently have 7 vehicles, with only 4 of them up and running.
  - The state is 5 months behind to pay them.
  - Currently, they are dealing with insurance not wanting to renew their policy unless they stop transporting young children in Crete.
